RE: Vision claims and coding guide

Aetna Better Health® of Oklahoma & EyeMed



Greetings provider partner,

When billing for vision services, providers must determine whether to bill EyeMed or Aetna Better Health based on the following criteria:

- <u>Bill EyeMed</u>: For comprehensive routine exams focused on eye wellness and prescription needs (using routine primary diagnosis).
- <u>Bill Aetna Better Health</u>: For eye exams related to medical conditions (using medical primary diagnosis).

Note: If refraction is performed during a medical exam visit, bill refraction to Aetna Better Health along with the medical exam.

Common routine vision diagnosis codes

The following ICD-10 codes should be used for routine vision care billed to EyeMed:

- **H52.0** Hypermetropia
- **H52.4** Presbyopia

• **H52.1** - Myopia

- **Z01.00** Eye exam without abnormal findings
- **H52.2** Astigmatism
- **Z01.01** Eye exam with abnormal findings

Important notes

- 1. No referral is required for Aetna Better Health members to see an in-network vision provider.
- 2. Providers must be contracted with EyeMed to provide routine vision services.
- 3. When billing for medical conditions, use appropriate medical diagnosis codes and bill to Aetna Better Health.
- 4. Many specialty lenses and materials require medical necessity documentation.
