Measure definition

Members with a diagnosis of type 1 or type 2 diabetes whose blood pressure is adequately controlled (<140/90 mm Hg) during the measurement year



Medical record requirements

- Member legal name and date of birth
- Provider/practice identifier
- Provider Business Group (PBG) name and number
- Date of service (DOS)
- Applicable lab/test results and date collected



Commonly used claim codes*

Systolic B/P:

- **3075F:** 130–139 mm Hg
- **3074F:** < 130 mm Hg
- **3077F:** ≥ 140 mm Hg

Diastolic B/P:

- **3079F:** < than 90 (80–89 mm Hg)
- **3078F:** < than 80 mm Hg
- **3080F:** ≥ 90 mm Hg

LOINC:

- **8480-6:** Systolic BP
- **8462-4:** Diastolic BP

Exclusions:

- Acute inpatient: **99221, 99222, 99223, 99231, 99232**
- Frailty encounter: **99504, 99509**
- ED: **99281, 99282, 99283**

Medical record submission methods may not be applicable to all plan types.

Required exclusions (Other exclusions may also apply)

- Members in hospice or using hospice services during measurement year
- Members who died during measurement year
- Members who had an encounter **or** received palliative care anytime during the measurement year
- **Medicare** members ages 66 and older as of December 31 of measurement year who meet **either** of the following:
 - Enrolled in an institutional SNP (I-SNP) anytime during measurement year
 - Living long-term in an institution anytime during measurement year

- Members ages 66 and older as of December 31 of the measurement year with frailty **and** advanced illness. Members **must** meet **both** frailty and advanced illness criteria to be excluded:
 - For frailty, at least two indications with different dates of service during measurement year
 - For advanced illness, either of the following during measurement year **or** year prior:
 - Advanced illness on at least two different dates of service
 - Dispensed dementia medication

Insights and recommendations

BP control (<140/90 mm Hg)

- Identify the **most recent** BP reading taken during measurement year
- If there are multiple BPs on the same date of service, use the lowest systolic and lowest diastolic BP
- Member reported BP readings during any type of non-acute visit, including telehealth visits are eligible for use when documented in the member's medical record
- Capturing BP value through CPTII value codes decreases medical record requests and chart review

Do not include BP readings:

- Taken during an acute inpatient stay or an ED visit
- Taken on the same day as a diagnostic or therapeutic test/procedure that requires a change in diet **or** change in medication on **or** one day before day of test or procedure (except for fasting blood tests)
- Taken by member using a non-digital device such as with a manual blood pressure cuff and stethoscope
- Without a distinct numeric result for both systolic and diastolic values; ranges and thresholds aren't acceptable
