Measure definition

Members who had the following vaccines by their second birthday:

- 4 diphtheria, tetanus and acellular pertussis (DTaP)
- 3 polio (IPV)
- 3 hepatitis B (Hep B)
- 1 measles, mumps and rubella (MMR)
- 3 haemophilus influenza type B (HIB)
- 1 chicken pox (VZV)
- 4 pneumococcal conjugates (PCV)
- 1 hepatitis A (Hep A)
- 2 or 3 rotaviruses (RV)
- 2 influenza vaccines (Flu)

For documented history of illness or anaphylaxis, there must be a note indicating date of event, which must have occurred by the member's second birthday.



Medical record requirements

- Member legal name and date of birth
- Provider/practice identifier
- Provider Business Group (PBG) name and number
- Date of service (DOS)
- Applicable lab/test results and date collected

Required exclusions (Other exclusions may also apply)

- Members in hospice or who used a hospice benefit in measurement period
- Members who died anytime during measurement period
- Members who had a contraindication to a childhood vaccine (Do not include laboratory claims) or organ and bone marrow transplants on or before their second birthday

Insights and recommendations

- Schedule follow-up vaccinations/doses at same time
- Emphasize the importance of vaccinations
- Administer Combo 3 and Combo 10 before child's second birthday
- Proper documentation is crucial to ensure vaccinations are recorded correctly
- Notation with specific name of antigen and date of immunization meets criteria
- Documented history of illness or seropositive test result must have date of event and must occur before member's second birthday
- Documentation that member received immunization "at delivery" or "in the hospital" meets criteria for vaccines that don't have age restrictions
- Documentation of anaphylaxis to any of required vaccines meets criteria for given vaccine
- If rotavirus doesn't indicate whether two-dose or three-dose, assume three-dose schedule
- Refusal of vaccines doesn't count as an exclusion
